Under date of December thirteenth, I transmitted to the Office a communication from Field Clerk H. E. House, of Muskogee, Okla., with reference to the enrollment of the Wa-co-che family. I have just received another communication from Mr. House requesting an answer, as there is a party of students which is ready to come on.


While I am not in favor of a family coming here as students, including the man, his wife and child, I shall do everything to cooperate, if the Office decides to grant them permission to come under the usual conditions governing the entrance of members of the Five Civilized Tribes. I have never had any experience with a married couple in a school during my connection with the Service, and am inclined to believe that it would be a difficult matter to handle. Possibly the thing could be solved by placing the woman in a good country home where she would learn practical house-keeping and cooking, and permitting the girl to stay at the school.

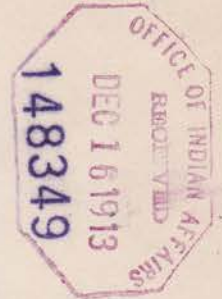
