Since writing my letter of May 26, 1886 it appears from representations from their Agencies and their parents that the following named boys were accepted by my Agent for a two year period viz

John M. Charles aged 18 yrs Pueblo Agcy from Laguna N.M.
 William H. Paisano " 20 " " " " " "
 Cyrus Dixon " 20 " " " " Wallace "

After considering the matter I think we had better comply with the agreement made and send these three boys in addition to the other named. This will make it necessary to procure transportation for two more to Laguna N.M. and one more to Wallace N.M.

On the third page of my letter of May 26, 1886 above referred to I asked for transportation books ways for one person in charge of party to Laguna
