## ASSIGNEE'S SALE OF REAL ESTATE.

The subscriber, Assignee of the estate of Abram J. Hendrickson, will expose for sale at public vendue on Friday, the twentieth day of October, 1905, between the hours of 12 and 5 o'clock in the afternoon of said day, that is to say, at two o'clock P. M., at the residence or dwelling house of said Abraham J. Hendrickson on the farm in the Township of Lawrence, County of Mercer, and State of New Jersey, upon which the said Abram J. Hendrickson now lives, all that certain tract or parcel of land and premises hereinafter particularly described, situate, lying and being in said Township of Lawrence and bounded and described as follows:

Beginning at a stone, being a corner to lands of William H. Dye and John Rue, thence with their lines south fifty-five degrees west twenty-six chains and fifty-six links to a white oak tree; thence along lands of Ephraim Phillips the several following courses and distances: (1) south eighty-eight degrees west and seven chains and twenty-five links to a stone; (2) south forty-six degrees and a half west two chains and forty-one links to a stone; (3) south thirty-three degrees and a half west two chains and seventy-three links to a stone; (4) south thirty-four degrees and one quarter, east two chains and thirty-two links to a stone; (5) south forty-seven degrees and a half, west eighty links to a stone to Henry Van Cleve's line; thence with his line north thirty-six degrees and a half, west seven chains and sixty links to a stone standing two feet west of a large hickory tree; thence south eighty-three and three-quarters degrees, west nineteen chains and forty-five links to a stone in William J. Dear Sir:

Your claim for services of Stephen Silverheels due from William Simpson, was duly received and presented to the sheriff. It cannot, therefore, be paid until after the other judgment creditors are satisfied.

At the time I wrote you I presumed it was a preferred claim, not thinking how much time had elapsed since he had left.

I will do all in my power, however, to collect this claim and upon collecting it will remit as requested.

All of the personal property of Mr. Simpson was levied upon and sold under an execution issued upon judgment with waiver held by the Odd Fellows of Doylestown. This personal property was not sufficient to satisfy their judgment.
