Washington, D. C.

SIR: In compliance with instructions,* I forward herewith a Descriptive Statement of certain changes in the Employé force at this ^{School} Agency, which I propose to make, subject to your approval.

* Instructions to Agents require that every change of employés shall be reported to the Commissioner, for his action, at the time such change takes place.

In the descriptive statement, the SEX may be designated by the letter M for *male* or F for *female*; the RACE by W for *white*, N for *negro*, I for *Indian*, H for *half-breed*, C for *Chinese*, &c., and the correct AGE is to be given when *known*; when it is *estimated*, a line should be drawn under the figures. S should represent *single* and M *married*.

These reports of "Changes in Employés" are not to be considered as a substitute for "Quarterly Reports of Employés." The latter must be made regularly and promptly, without regard to these.
