Sir:-

When making my nominations last year I thought it practicable to do without the Agent for Out pupils; but now find that it is better that we have one. I find that I can very well use the same party in connection with Store keeping and property matters for such portion of the time as he is not required to be looking after Out pupils, and so dispense with the services of a Storekeeper at \$300.⁰⁰ per Annum.

I respectfully request to be allowed an Out Agent at Nine hundred Dollars (\$900.⁰⁰) per Annum, and to dispense with a Storekeeper at Three hundred Dollars

($\$300.00$) per Annum. We have out from the School, at the present time, one hundred and seven (107) Students.

In anticipation of approval, I forward herewith descriptive list of proposed changes, on which I transfer, by nomination, Mr. Richards from Clerk to Out Agent, and nominate C. H. Hepburn, who has previously been in the School service for three years as Physician and Clerk, to the position of Clerk.

* Instructions to Agents require that every change of employés shall be reported to the Commissioner, for his action, at the time such change takes place.

In the descriptive statement, the SEX may be designated by the letter M for *male* and F for *female*; the RACE by W for *white*, N for *negro*, I for *Indian*, H for *half-breed*, C for *Chinese*, &c.; the correct AGE is to be given when *known*—when it is *estimated*, a line should be drawn under the figures; S designates *single*, and M *married*.

The reports of "Changes in School Employés" are not to be considered as a substitute for "Quarterly Reports of School Employés." The latter must be made regularly and promptly, without regard to these.
