Sir:

I have the honor to forward here-
with copy of letter from Agent Williams,
of Cheyenne & Arapaho Agency, in re-
gard to sending six Indian youth to
this School. In addition to what is
indicated in his letter I only know,
in regard to the matter, that two
boys of the Arapaho School wrote
me, requesting to be allowed to come
to Carlisle. I replied to them to
make application to their Agent.

Six seem to be hardly a suffi-
cient party to warrant the expense
of an escort; but I am willing to
concur in allowing the expenses from

our Appropriation, if the Department approves of it. Probably, when they begin to make up the party, it will be found that ten or twelve suitable pupils can be had. Instructions and authority are respectfully requested.
