Receipt is acknowledged of your letter of June 26, 1919, relative to the date of your enlistment in the Navy.

In this connection you are advised that the records of Carlisle Indian School show that you were on leave from December 14, 1917. The reports ending March 31, 1918 show that you were dropped January 14, to join the Navy. You were considered a member of the Carlisle Indian School until January 14.

I trust that this will correct any misunderstanding as to the date you left Carlisle Indian School.

It is suggested that you file this letter with your application for discharge, which will be evidence that you were a student in Carlisle Indian School prior to your enlistment in the Navy.

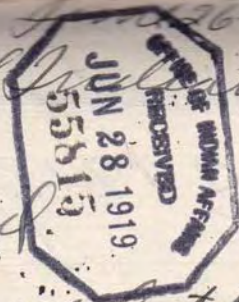

My Friend:

I have your letter of May 17 regarding your brother Wesley Aaron, who you state desires to be discharged from the Navy in order that he may continue his school course.

In answer you are advised that I was not able to take the matter up for your brother for the reason that his address was not given. However, your brother should make formal application to his commanding officer for a discharge, as it is unlikely that any consideration will be given requests for discharge from outside sources until the sailor involved has made application for discharge.

The records of this office show Wesley Aaron to have been a student in the Carlisle Indian School at the time he enlisted in the Navy, January 14, 1918. You should forward this letter to your brother who should file same with his application for discharge.

Mr. Oscar H. Lipps is now Supervisor in charge of Chilocco Indian School, Chilocco, Oklahoma.
