

Referring to Indian Office letter of August 7, 1909, marked "Education, Administration, 51264, 43385, 53977, 57760 and 60432, 1909, E.A.F. QJHD.FTP.EPH.)" relative to a dispute between Jennie L.Gaither, Matron of this school and myself, and in compliance thereto as requested, I have to respectfully state that while I do not for a moment question the integrity and veracity of Miss Gaither, nor do I have any recollection of calling her a name such as she accuses me to have said, but if I did use undignified and discourteous language to her in a moment of anger, I do most truly and sincerely apologize to Miss Gaither, and hereafter endeavor to so conduct myself amicable and with proper courtesy, and to cooperate with Miss Gaither in the proper discharge of our respective duties for the best interest of the school.

I beg to note in this connection and which I feel is absolutely necessary and fair and conducive to preserve proper harmony and discipline and that is that Miss Gaither should not endeavor to exercise any unjust discrimination against me for any reasonable request which is in her province to grant, and eliminate an attitude which is detrimental to proper personal and official relation.

Sir:-

I have your Office letter marked "Education, Administration 51264-1909; 43385-1909; 53977-1909; 57760-1909;
60432-1909, E.A.F., "dated August 7,1909, concerning the dispute
between Jennie L. Gaither and S.J.Nori. A copy of this letter
was given to Mr. Nori for his guidance and I believe he visited
Washington for the purpose of interviewing you concerning the
matter. Mr. Nori is at present away on his vacation. During
his visit to Washington, he probably indicated what action he
would take in the controversy.

Regarding the matter of special privileges being granted Mr. Nori, I respectfully state that, as to this, your Office has been misdinformed. Mr. Nori, in common with all other persons employed at this school, has never enjoyed any special other privileges that could not consistently be given to any/member of the faculty, and still conserve the best interests of the institution as a whole. When Mrs. Nori was sick in bed, with a newly born the child, Miss Gaither refused to assign a girl to/Nori household. Mr. Nori

appealed to me and I gave instructions that he be furnished with a girl the same as any other married employee.

I have given Miss Gaither absolute charge of the girls' building, and her work has not been interferred with; to the contrary, she has been backed up at every point and, during my tenure of office here, to the extent of allowing two assistant matrons to resign because they claimed that an undue proportion of the work in that building was thrown upon them.

I also report that in the assignment of girls, Miss Gaither has had difficulty with other employees besides Mr. Nori. Although Miss Gaither has charge of the girls, your Office holds me responsible for the way in which she discharges her duties and when these are manifestly not discharged properly, or with justice to all, and in the interest of the school and the student body, it is imperative that some one interfere.

Mr. Nori is one of the best employees at Carlisle, he is quiet, faithful, efficient and unassuming, and from his past record, and native excellence as a man, would not, I believe, ask for, nor expect, anything which was not his due.
