Wm. Newashe, being duly sworn by Inspector E. B. Linnen, deposes and says:

- Q. Please state your name, age, and address.
- A. Wm. Newashe, 25 years old, Paxtang, Pa.
- Q. You were a former student of this school, William?
- A. Yes, sir.
- Q. When did you complete your term at this school?
- A. I didn't finish, but I left in 1911, I didn't finish school.
- Q. You left in 1911, that was the date your term expired?
- A. In 1908 was when my enrollment expired, but I never signed any papers or re-enrolled after that.
- Q. What tribe do you belong to, William?
- A. Sac and Fox of Oklahoma.
- Q. Did you used to play football on the first football team at Carlisle?
- A. Yes, from 1900 to 1911, first team; in 1908 I was substitute.
- Q. After 1908, when you say you were no longer enrolled, you played football each fall for several years, didn't you, on the first team?
- A. I played in 1909, 1910, and 1911, for three falls.
- Q. And were your fare and expenses paid by the Athletic Association of Carlisle?
- A. Only once, in 1911, from Ft. Wayne here.
- Q. And you played on the football team those years when you were not an enrolled student at the school?
- A. Yes, sir.
- Q. Did you ever receive any payment or consideration for playing football those years?
- A. In 1908 I got \$100 for being on the football team as a substitute.

- Q. Were you paid after that?
- A. No, sir.
- Q. Well, didn't you receive any consideration?
- A. Not a thing. The only promise Mr. Warner gave me when he wanted me back in 1911, he said if I wanted a coaching job, but he sort of half way gave over considering me to be fit for a college team, of some sort you know. That is the only thing he ever promised me, which I never did.
- Q. Was it always Mr. Warner who wrote you to come back and play football?
- A. Let me see, now. I can't swear to that. I don't know. But I know pretty nearly all the letters I got were from Mr. Warner.
- Q. During the time that you were playing football under Mr. Warner, did you ever hear him use profane and obscene language and curse any of the football boys?
- A. Well, during the games he does, but around here I never heard him.
- Q. But you have heard him curse the boys during the games?
- A. I couldn't recall the instances, I know he did but I couldn't recall to prove, but I have heard him.
- Q. What did he say?
- A. Well, he would, suppose a man, he did in several instances, I can't hardly recall. If somebody wouldn't play the game, he wouldn't say, he would say "Damm it, you aren't playing the game, damm it, give in." That is the only sort of a statement he made.
- Q. During the falls of 1909, 1910, and 1911, when you played football with the team, it was generally given out and supposed that you were one of the students here at Carlisle?
- A. Yes, sir.
- Q. Didn't you ever receive any suits of clothing, or overcoat, on account of playing ball?
- A. Yes, sir. Every fall they would grant the men to go down town and get fifty dollars worth of credit on the different clothing stores, and maybe he would give us a souvenir, or watch of some sort.
- Q. So then, as a matter of fact, each year you got \$50 in clothing and a souvenir watch, or something of that sort?

- A. Yes, sir.
- Q. And your expenses while you were here playing, and elsewhere, were always borne by the Athletic Association?
- A. While I was here, yes, sir.
