Mary P. Ropes, Salem, Mass., died in 1903, willed to the Carlisle Indian School, as per provision of the will; "To the Carlisle Indian School, Pennsylvania, I give \$2500.00."

Eliza O. Ropes, Salem, Mass., died April 10, 1907, provision of the will states "To the Carlisle Indian School, Pennsylvania, I give \$2500.00."

First payment on legacy under will of Mary P. Ropes, Apr.15, 1908, -\$1250.00. Amount deposited Merchants National Bank, Carlisle, Pa., to await further instructions from Indian Office and administrators of the estate, relative to appointment trustees.

Payment under will of Eliza O. Ropes, April 15, 1909, ---- \$1500.00. + 1/64.03 = #2664.03

Balance under will of Eliza O. Ropes, June 8, 1909, ---- \$1164.08, same being balance of legacy and inserest on legacy for \$2500.00.

Balance of legacy under will of Mary P. Ropes, sister of Eliza O. Ropes, on account of deficit in the estate and certain questions of law arising, will probably not be settled for some time. (See letter Chas. W. Richardson, June 8, 1909.)

"I thank you for your advice on the matter of the legacy from Miss Mary Ropes. I have taken the matter up with Judge Wetzel, and the court will probably appoint the Merchants National Bank of Carlisle as trustee of the fund, provided there are no legal difficulties in the way. Your suggestion that only the interest be used and that it b given to deserving students in the nature of a loan is a good one, and I shall be guided by it."

Extract of letter written to former Commissioner Francis E. Lettpp, June 26, 1908. by Friedman, Supt.

WILL of Anna E. Peale of Philadelphia, who died December 7, 1905.

"Fifth: I give and bequeath to the United States Indian Industrial School at Carbisle, Cumberland County, Pennsylvania, the sum of Three thousand dollars in trust for the maintenance and education of Indian girls at the Training School at Carlisle Barracks, Pennsylvania, and I direct that the said sum be paid to Dr. C. R. Agnew of New York City, Captain R. H. Pratt of the United States Army and Bishop William H. Hare, whom I constitute and appoint Trustees to manage and apply the same in such manner as they may deem best for the purpose above mentioned and in case any of the Trustees should fail to serve or from any cause whatever by death incapacity or otherwise be unable to do so, I hereby authorize the remaining trustee or trustees to fill the vacancy by the appointment of such person or persons as they may deem fit or failing any such trustee or trustees willing or able to act then I authorize the proper Court of Cumberland County aforesaid to appoint the needful number of trustees to carry out the purposes of this trust."

Dr. Agnew is dead, Bishop Hare declines to act, General Pratt resigned trusteeship.

Order of Fourt.

And now 7" May, 1907, the Court having heard the foregoing petition and after due consideration do hereby appoint Messrs.

W. A. Mercer, John Lindner and J. W. Wetzel, trustees, successors to the trustees named by the testatrix Anna E. Peale to receive and manage the trust fund bequeathed by her to the United States Indian School at Carlisle, Penna. for the maintenance and education of Indian girls at said school, in accordance with the terms of the said bequest, bond with surety in the sum of \$5000, for the faithful performance of the duties of the trust is required to be filed and submitted for approval.
