Sir:

Referring to your Office letter (Education 83078 and 87258-07, Filen162) dated the 2d instant, informing us that Miss Florence W. Silverheels had notified you that she does not feel capable of taking the teacher examination, and inquiring whether we have any one else in mind to recommend for the position now vacant here at \$480 per annum, you are advised that we have not thus far been able to learn definitely about any teacher who would be eligible to the position or who would likely be able to pass the required examination. However, we are now in correspondence with two parties in regard to the place. One of these is Mrs. Julia Powlas Wheelock who, when last heard from, was employed at Wind River Indian school, Shoshone Agency, Wyoming, as Laundress. Last winter Mrs. Wheelock. shortly after the death of her husband, applied for a transfer to this school, but at that time there was no vacancy. We understand that some years ago (perhaps 8 or 9) she was employed as a teacher on the Oneida reservation. Wisconsin. From this it is inferred that she would be eligible to transfer to the vacancy here as teacher.

She has two children, we understand, aged about 12 and 14 years, who, in the event of the transfer, would be regularly enrolled as

pupils, if found eligible.

We have written Mrs. Wheelock, through the Superintendent at the Shoshone Agency, asking her whether she would be willing to accept such a transfer if it can be arranged and meets with the approval of your Office. Please advise us whether Mrs. Wheelock is eligible for transfer to the vacancy in question and if so whether the transfer would meet with the approval of your Office.

Answering further your letter of the 14th ultimo, with reference to the eligibility of Mrs. Julia Powlas Wheelock for appointment as Assistant Teacher at the Carlisle School, you are informed that the Civil Service Commission has just notified the Indian Office that a search of their records both under the name of Powlas and of Wheelock fails to show that she has passed the examination for Teacher or Assistant Teacher; that she failed in the Assistant Teacher examination in 1904.

Mrs. Wheelock is therefore not eligible. Do
you know whether she would care to try the examination again,
and if she does not, have you any other Indian to suggest
who would likely be able to make an eligible percentage?
