Sir:

I am in receipt of your letter of the 3d instant (Education 90529/07 File 162, 93424/07 File 833) stating that you have just been informed by the Civil Service Commission that a search of its records fails to show that Mrs. Julia Powlas Wheelock has ever passed examination for teacher or assistant teacher, and that she failed in the examination for assistant teacher in 1904.

In reply I have to state that no response has been received from Mrs. Wheelock or the superintendent at Shoshoni Agency, Wyoming, in regard to her transfer here. The matter has again been taken up with the superintendent but in view of the report made by the Civil Service Commission it is doubtful whether it is best to depend upon effecting Mrs. Wheelock's transfer to the position of teacher here.

I inclose herewith a copy of a letter dated the 16th ultimo from Ella Petoskey, a graduate from this school of 1904. It will be noted from her letter that she is willing to take the required examination and it is believed that she would be able to make an eligible percentage. We hesitated somewhat to suggest her giving up her work in college to enter the service, but as it appears she

arrangements be made for her to take the required examination, if it can be arranged for Dr. G. J. Edgcumbe, president of Benton Harbor College to conduct the examination. It is hardly deemed best to ask Miss Petoskey to come to Carlisle to take the examination and assume the risk of failure. I should like to be advised of your action in the premises.
