Sir:-

I have your Office letter, "Education 49873/08, WAM", dated July 25,1908, stating that Miss Ida F. O'Neal declined the position of assistant matron at this school and asking for recommendations.

In reply, I respectfully recommend that this position be abolished and that I be granted authority to detail Mrs. Allie B. Carter, at present assistant matron in the small boys' building, to do the work of assistant matron in the girls' building.

Acting upon the recent regulations sent out by your Office concerning the New York Indians, I have sent home practically all the boys and girls under the age of fourteen from
that State. These children constituted by far the largest
number of children under fourteen years of age who were enrolled



at this school. The reason for having a woman in the small boys' building has been the presence of so many of the small children necessitating the care of a woman. Inasmuch as there are not over half a dozen of these smaller boys in the small boys' home, the reason for having an assistant matron in that building has been done away with. I am of the opinion that the disciplinarian and his assistants can satisfactorily take charge of this work. For your information, I would say that at present Mr. Harry M. Carter is disciplinarian in charge of the small boys! home at a salary of \$720.00 per annum.

If your Office concurs in my recommendation, it would simply be necessary to abolish the position of assistant matron now vacant, and I could then detail Mrs. Carter to do this work.
