I have to request that I be relieved from duty as Superintendent Carlisle Indian School, to take effect December 31, 1907. and ordered to join my regiment when I shall have completed the transfer of public funds and property for which I am responsible.

I further request that the order relieving me state I am relieved at my own request.

Though in good physical health, I have, for several months past, experienced, at frequent intervals, severe pains in my head, - with consequent temporary loss of brain power, and I find the daily annoying responsibilities all more than I can stand and am advised by my physician that I should have relief from them, and take a few months leave of absence. Such a course followed by a change back to the more out of door military life, I am convinced is a necessity, and that relief as above will best suit

Major W. A. Mercer's request to be relieved from duty at Carlisle School.

Major William A. Mercer,

Acting Supt. Indian School,

Carlisle, Pennsylvania.

Sir:

I am in receipt of your letter of the 10th instant, requesting that you be relieved from duty as Acting Superintendent of the Carlisle Indian School, to take effect December 31, 1907, and that you be ordered to join your regiment when you shall have completed the transfer of public funds and property for which you are responsible.

You say:

"Though in good physical health, I have, for several months past, experienced at frequent intervals severe pains in my head, with consequent temporary loss of brain power, and I find the daily annoying responsibilities all more than I can stand and am advised by my physician that I should have relief from them, and take a few months leave of absence. Such a course, followed by a change back to the more out of door military life, I am convinced is a necessity, and that relief as above will best suit the conditions."

As you so urgently request to be relieved of your present responsibilities, I will recommend to the Secretary of the Interior that the War Department be asked to revoke your detail

as Acting Superintendent of the Carlisle Indian School, and that you be ordered to join your regiment when your relief at Carlisle has been effected.

Owing to the magnitude of the fiduciary responsibilities incident to the control of so large an institution as the Carlisle school, and the limited time between now and December 31, I shall be unable to have you relieved on that date, but may be able to relieve you between the middle and the last of January. I shall accomplish it as early as I possibly can. If your successor has not been selected and become qualified, the school will temporarily be placed in charge of either a Supervisor or a Special Agent, so that you may return to your regiment not later than February 1.

The granting of your request for relief, which you have simply forced upon the Department by your statement of insuperable reasons why you cannot continue longer under the strain of your present heavy burdens, must be the subject of very great regret to all in Washington who have had to do officially with Carlisle School since you took charge of it as Acting Superintendent. No one could stand in such relations to your work without admiring your loyal devotion to duty, your prompt and cheerful efforts to carry out the policy of this Office, and your unqualified success in bringing up the standards of discipline and giving to the institution generally a wholesome

I have the honor to say that the Commissioner of Indian Affairs is in receipt of a letter from Major William A. Mercer, U. S. A., Acting Superintendent of the Carlisle Indian School, of date December 10, asking to be relieved from duty at that school to take effect December 31, 1907, and that he be ordered to join his regiment when he shall have completed the transfer of public funds and property for which he is responsible.

In his letter Major Mercer says:

"Though in good physical health, I have, for several months past, experienced at frequent intervals severe pains in my head, with consequent temporary loss of brain power, and I find the daily annoying responsibilities all more than I can stand and am advised by my physician that I should have relief from them, and take a few months leave of absence. Such a course, followed by a change back to the more out of door military life, I am convinced is a necessity, and that relief as above will best suit the conditions."


I am informed by the Commissioner that Major Mercer has been written that as he so urgently requests to be relieved from his present duty you would be a ...

but that owing to the magnitude of the fiduciary responsibilities incident to the control of so large an institution, and the limited time between now and December 31, it would be inadvisable to have him relieved on that date, though it might be possible to relieve him between the middle and the last of January; and that if his successor has not been selected and become qualified the school would temporarily be placed in charge of either a Supervisor or a Special Agent, so that he might return to his regiment not later than February 1.

As Major Mercer has asked to be relieved of his present detail, I respectfully recommend that the War Department take the necessary steps for its revocation, to take effect as soon as his successor can be appointed and become qualified, but in no event later than February 1, 1908.
