Sir:-

I have your Office letter marked "Education 47009-08, W.A.M.," dated July 18, 1908, in which a letter from Superintendent of Haskell Institute is quoted to the effect that I have been corresponding with Mr. Olson, and other employees of his school with a view to getting their services for Carlisle and in which connection, an explanation is desired.

I am sending, under this cover, all the correspondence had with Mr. Olson, concerning this matter. It will be noted from this correspondence that the original application for transfer to this school was made by Mr. Olson.

The Superintendent of Haskell also states that I have corresponded with other employees of his school. In answer to this, I desire to state that in the short time I have been here, I have received applications for transfer to this school from the following Haskell employees:- A.V. Wristen, Miss Anna Bowdler, Miss Martha Kaufman, Miss Annie Triplett. In each of these

instances, the request for transfer originated with the above named parties, and they were replied to stating that no position was vacant to which they could be appointed. I might have transmitted the letters of these parties to the Superintendent of Haskell Institute, and informed him that some of his employees were desirous of coming here, but I desisted from doing this for the reason that, having been an employee at Haskell Institute myself, I knew that it would be very unpleasant for these employees if the former knew of their desire to leave.

I have no desire to interfere with the employees force of that school, and shall refer any applications to the Indian Office relating to their transfers.

In this connection, I desire to inform your Office that the Superintendent of Haskell Institute has overlooked a case in which he has been doing the very thing which he believes is so harmful to the Service. The sincerity of his communication may well be questioned when it is known that recently, - I believe it was the 15th of April, - he sent a communication to Mr. E.K. Miller, printer of this school, asking him if he would not accept a position at Haskell Institute. It was generally known throughout the Service at that time that Mr. Miller had already been transferred from the Chilocco school to Carlisle.

If any correspondence which I have had was against the regulations of the Indian Office, I regret it.

In reply, I have to inform you that the position of baker is vacant at this school; the salary is \$600.00. We have a cracker machine here, and I am writing to ascertain if you have had any experience in cracker making, and could run such a machine in addition to the regular baker's work.

If a married man is appointed ^{to} the position of baker, we could probably arrange to give him quarters. We could at least give him a suite of two or three rooms.

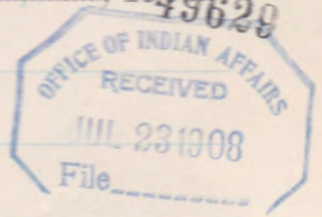

I am what is known as a 'bread and cake' baker.

I can do the cake work of a cracker shop, but have never made crackers, i.e., soda crackers, which latter is regarded as being a separate trade.

I thought that since the trades are to be taught that a baker would be necessary and as a matter of course would be paid not less than \$720,
