Sir:

The Office has had under consideration your letter of October 23, 1913, in reference to certain checks now in the possession of the school banker which have been sent you to be turned over to the students, and notes the two requests with which you conclude your letter.

You ask that some way be evolved to regulate the sending of large checks or even of checks of any kind direct to students at the school unless the money is placed to their credit on the books and treated the same as all other moneys of all other students. Section 16 of the Regulations for handling Individual Indian Money does not limit the amount to be remitted nor can this always be done arbitrarily even if it might seem advisable to do so. It is, however, stipulated that such transfer of funds shall be made to the disbursing officer and strict compliance is always expected and insisted upon.

when any such check is received regardless of smount or source of funds, the individual for whom the check is intended should be asked to endorse it over to you as Superintendent, and the proceeds placed to his credit as Individual Indian Money, Pupils. Refusal on the part of the pupil to endorse check should be promptly reported to this Office for consideration, giving full particulars as to the reasons advanced by the pupil for such refusal, and your own recommendations.

Your letter says that these checks are sent to the students for one reason or another after approval by this Office and according to the regulations they are turned over to the students so that the money is expended without any further supervision. This reference to the regulations is not understood. On the contrary, in accordance with the terms and conditions laid down in Section 11 of the regulations for handling individual Indian money, you are expected to supervise the disbursement of all individual Indian moneys.

You also ask favorable action with reference to a general authority to close out the accounts of students who return to their homes.

It is believed that you have sufficient authority in sections 14 and 16 to cover all ordinary cases of this kind. If cases arise in which Indian pupils, when at home, will not be under the jurisdiction of any Superintendent, the paying over to them all of their savings should be made the subject of special correspondence with this Office. Every request of this kind must be full and complete, accompanied by such statement of competency as will enable the Office to act promptly on your request.

Sir:

Referring to the above described letter , I have to say that the pupils in whose favor these checks were drawn are Pawnee Indians over eighteen years of age; that the funds against which these checks were drawn are "Fulfilling Treaties with Pawnees. Oklahoma" and "Interest on Pawnee Fund". The authority for the disbursement of these funds is No. 114980013 granted September 30, 1913. The checks were not sent to the pupils direct but were sent to the Superintendent of the Carlisle school with the advice that they represented the shares of the students of the annuity payment. Copies of these letters transmitting these checks are attached hereto. Had these pupils been at home they would have received these checks direct the same as all of the other adult annuitants. In sending the cheeks to the Superintendent we expected that they would be handled in accordance with the regulations of the Carlisle school and we did not ask that they be turned over to the students to be used without restriction. The payment of these funds to annuitants who are legally competent to receive them is provided for by treaty and the authority under which this particular payment was made states that the payment is mandatory.

Our records show that there were but six of these checks transmitted instead of ten as stated in Department letter.

Besides a large number of smaller checks, the school banker has now in his possession to be turned over to students according to the regulations, the following checks:

Arthur West, Winnebago per capita payment,
check No. 615, amount,\$317.90

John Armell, ditto, check No. 540, 317.91

Ethel Greenhair, ditto, " " 567, 317.91

Pawnee pupils (ten annuity checks of \$36.60 ea.)366.00

Silas White, Treasury Warrant, No. 1955, 151.25

Joseph H. Broker, White Earth Agency, check 1456,450.00

These checks are sent to the students for one reason or another after approval by your Office, and according to the regulations they are turned over to the students, so that the money is expended without any further supervision. While the students draw them for a stated purpose, there is no assurance that the money will be spent for that purpose, unless the funds are placed under exactly the same conditions as all other funds of those and other students.

According to the new regulations issued, paragraph

1th

11, page 5, a small allowance of spending money is granted, while there is another provision making it necessary to obtain authority in each case where over \$25.00 is expended, regardless of the fact of whether the student has earned this money himself or has obtained it through his agent in the West. The present method of sending checks to students, as quoted above, is harmful in two ways.

First, it encourages extravagance among a certain number of students whose extensive expenditures are not supervised and cannot be after the money is turned over to them.

Second, a few students having more money spend large sums, while other students in large numbers are held to very small expenditures, according to the regulations, causing dissatisfaction and a feeling among those who are held down that favoritism is practiced.

cause it seems to me and to other attaches of the school that some adjustment should be made. At the same time, I respectfully call attention to the difficulty in closing out the accounts of the students who return to their homes. Most of these students earn all the money which they have in their possession in the school bank, and some of them are not under the immediate jurisdiction of the Superintendent of a reservation, such as the New York students. I have

made it a practice here that whenever a student goes home who lives under the jurisdiction of an agent and has a large sum of money to his credit, say \$50,00 or more, that the money has been sent as "transfer of funds" to the superintendent of the reservation. A large number of students, however, do not come under such jurisdiction and the delay incident to sending their money causes dissatisfaction among them and a feeling of anxiety.

I am strongly in favor of the students being held down in their expenditures while they are in school, and it has always been the practice of the Carlisle School to insist on the students saving half of their money even though it is earned under the Outing System.

I merely submit these two matter, first, that some way be evolved to regulate the sending of large checks or even of checks of any kind direct to students here at the school, unless the money is placed to their credit on the books, and treated the same as all other moneys of all other students. Second, I respectfully request favorable action with reference to a general authority to close out the accounts of students who return to their homes.
