My dear Sir:

I am having copied below for your information a copy of a letter that has just been received here from Mr. S. A. Morton, the Cashier of the Mount Hermon School at Mount Hermon, Mass achusetts:

"I have just received check for \$150.00 from Mr.
Davis, Rosebud, S. D., on account of Louis Schweigman.
Mr. Davis writes "on account Louis Schweigman to be
kept by you for the school expenses of Schweigman".
Now Schweigman wants this money turned over to him,
saying that he probably will not return to school after
this fall term. His bills are paid and there is a balance out of this \$150.00 of \$121.78 to his credit.
Would you advise letting him have this in such
amounts and at such times as he may call for it?"

As it is indicated in the part of your letter that is quoted by Mr. Norton that the money was sent for a definite purpose I am taking the liberty to state that it should not be expended by Schweigman for any other purpose than that designated until specific authority is given by you for its use as may be desired by the young man.

My dear Sir:

I respectfully submit below for your information a copy of a letter that has just come to me from Dr. H. F. Gutler, the Principal of the Mount Hermon School at Mount Hermon, Massachusetts, where Louis Schweigman has been in attendance for about a year:

"I have just been talking again with Schweigman about his expenses. He has not yet received any remittance from the Government and seems to be rather anxious about the matter. Is there anything that I ought to do in making any reports so that the payment may not be delayed? I am sorry to write you again about this matter, but I am quite dependent upon you, as I do not know the method of procedure in regard to the payments by the Government. I understand that the amount is due Schweigman from the Government, and you, of course, know just what he ought to expect.
