Sir:

In compliance with Office letter of the 27th ultimo,
I have the honor to return herewith the lease with the
Henderson Heirs, completed as required, and accompanied
by my oath of disinterestedness.

While the school does not make any extended use of this
land, it being used for a short period as pasture for the
dairy cows and a small portion of it as a skating ring in
winter, still it is located so near the school campus that it
is feared there will be no end of trouble unless the school
keeps control of it as it would be almost impossible to keep
the Indian boys off of it. For this reason I recommend
that the lease be approved.

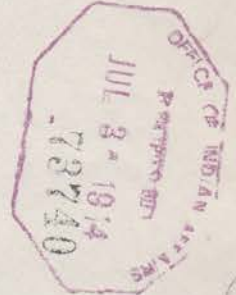
