Sir:

Reporting as was directed in Office letter of May the 11th, this is to convey the information that there are but two students enrolled here now who are affected with tuberculosis. Our physicians' reports in regard thereto are copied below:

"Louise Bluesky has been in the Hospital since January 5th, 1912, with a mild case of pulmonary tuberculosis, having slight evening temperature elevations. She has gained in weight weekly since here and is improving daily".

"James Catfish has been in the Hospital since March 18, 1912, with a mild case of pulmonary tuberculosis with slight evening temperature elevations, never above 100. He has gained greatly in weight since here and is improving in his general conditions daily".

Reports death
of student.

Sir:

It is with regret that I report to the Office the death of James Pawnee Leggins, a member of the Sioux Tribe who was enrolled here from Kyle, South Dakota. The young man was admitted to the school hospital on April the 6th, suffering with hemorrhages from the lungs. He did not have a hospital record previous to such date and at no time during his illness was he strong enough to be moved to his home. There was no recurrence of the hemorrhages after the 13th instant, but the resultant fever of the tubercular condition and the weakness following the hemorrhages was the immediate cause of his death, which occurred last night.

Funeral services have been arranged for tomorrow forenoon, to be attended by all students, after which the remains will be shipped to Rushville, Nebraska, accompanied by a cousin, Henry Red Owl.
