I have your letter of June 4, 1912 concerning the attendance of students from the Carlisle Indian School at your historical pageant to be presented in Philadelphia during October next, and shall be glad to have the students attend unless the Superintendent of the School knows of some reason why they cannot go this year. Mr. Friedman has been communicated with and requested to write to you and assist in arranging the details of the matter.

In 1908 sixty boys and five girls were sent from the school with two escorts for the boys and one for the gigls, and I presume substantially the same arrangements will be necessary this year. It would be desirable that the girls be not required to march in the parade, and also quite essential that all students wear their uniforms during all times except while actually in the procession.

Your letter of June 30 was duly received, in which you ask that about seventy Indians from the Carlisle School, or some other institution within reach of Philadelphia, be permitted to appear in an Historical Pageant to be given in connection with the celebration of the 225th Anniversary of the founding of that city.

The matter was taken up with the Superintendent of the Carlisle School, and I have to-day authorized him to permit sixty young men and five young ladies to appear in the street parade on October 9 under the following conditions:

1. That all their transportation expenses are paid by you, together with board and lodging in a hotel or boarding house in a good location in the city of Philadelphia.

2. That all the expenses of two escorts for

the boys and one escort for the girls are paid by you.

- 3. That the girls are not required to march on foot.
- 4. That the students are to appear in their regular uniforms except during the time they are actually in the procession.

As delays often occur on these occasions, and the line of march sometimes covers several miles, it was thought that to require the girls to march on foot would prove a hardship.

If the conditions are satisfactory, you should arrange the time for the arrival and departure of the students with Superintendent Friedman of the Carlisle School.

In further reply to your Office letter Education 44180/08, EAF, dated July 10,1908, concerning the request of the Director of a Mistorical Pageant that seventy Indians be permitted to appear in a street parade, I respectfully transmit, under this cover, a letter just received from the Director of the Pageant in answer to a communication from me in which I requested certain information. It will be noticed from the letter of Director Oberholtzer that the procession and exhibition is of a legitimate character, and would probably not conflict with the ends and purposes of our work.

I respectfully recommend that the school be authorized to assist the City of Philadelphia in their endeavor to give this Historical Pageant. I would suggest that sixty young men and five young ladies be sent under the following conditions:-

1st. That all of the transportation expenses be paid, to-

gether with board and lodging in a hotel or boarding house in a good location in the city of Philadelphia.

and one escort for the girls be paid. I do not believe it would be well for the girls to march on foot as is suggested by the Director. Those parades are quite often delayed for some time, and besides the long wait, those who take part are often compelled to march five or six miles, and sometimes more. This would be a hardship on the young ladies.

3rd. That the students go in their uniforms and remain so attired, excepting during the time when they are actually in the procession. I believe this is necessary for the reason that it might be requested by the management at Philadelphia that they go about the streets garbed in the primitive manner in which they would appear in the procession.

Dear Sir: -

I have your kind favor of the 11th instant, in reply to my earlier request in regard to some 60 or 70 Indians from your school.

The Historical Pageant, which we are planning for the 9th of October next, is in connection with the Founders' Week celebration, which is being arranged to mark the 225th anniversary of the foundation of the City of Philadelphia.

There will be a number of processions but the most important and interesting we hope will be that which is designed to illustrate the history of the city, and is set for Friday of the week. It is planned to begin the procession with the scene representing the life of the Indians on the Delaware, before the Dutch, the Swedes and the English arrived. A handsome car has been designed by Miss Violet Oakley and its construction will be under

the direction of Mr. Charles Stephens, who has made so close a study of the Indians. This will be followed by floats, cars and moving people to represent the various phases in the history of Philadelphia, including the Revolutionary period, the War of 1812 and the Civil War. The Pageant throughout is made up of costumed people from the dress of the periods which are to be represented, and much attention is being given to historical detail.

The University of Pennsylvania, Haverford College and most of the institutions in and around Philadelphia will send students to take part in the Pageant, and it occurred to us that we should have a number of Indians from your school for the Indian scene. We should need 10 men on the car and five or six women. We have planned for 50 figures on the street, on foot, to accompany the car. These could all be men but, if possible, it would be desirable to have three or four girls on foot also, if they did not consider it a hardship.

As I said before, the costumes will be designed and made here. They will be ready to wear when the students reach here. If they can add anything, however, in the way of material which it would be well to carry in the procession we should be very glad to have them do so.

P. S. This will be the first Historical Pageant to be given in this country, although many are being seen from time to time in England. Quebec is about to undertake such a representation next week.

The float represents an Indian hut of the day, studied from the accounts of the Lenni Lenape Indians. In front of it are seated some 10 Indian chieftains in a Council of Peace; two or three women are standing or seated at the door of the hut grinding corn and tending one or two children.

I think that the students could leave the school on Thursday afternoon, reaching here in time for rehearsal on Friday morning, and return again on Saturday.

I do not think that you would find anything in the representation that would be at all hostile to the purpose of the school, and I wish that I might be able to show you the drawing of the float which Miss Oakley has prepared. I will make arrangements to do this if you prefer it.

We have in hand in Philadelphia a celebration of the 225th Anniversary of the foundation of the city.
