Request to place  
children at Carlisle  
School.

My Friend:

The Office has received your letter of May 10, 1909, requesting that your two daughters, 9 and 10 years old, Iroquois from St. Regis, New York, be placed in the Carlisle School.

The Indian School Rules do not permit the enrollment of New York Indians at any other nonreservation Indian schools than Carlisle. Because of the provision made by the State for the education of Indian children in schools near their homes, this prohibition has lately been broadened so as to exclude New York children from Carlisle also, unless they have first attended the home schools and are ready for industrial or trade courses. In accordance with this policy, the number of New York children now at the school is being reduced. A further bar to the enrollment of your children at Carlisle is the issuance of an order prohibiting the acceptance of any children in the nonreservation schools who are not fourteen years old or over.

It is suggested that you place the children with relatives or friends at St. Regis, or see if you cannot have them placed in a State boarding school for Indian pupils, such as the institution in Cattaraugus County, of which you probably have knowledge.
