Referring to Office letter of November 2nd, 1909, marked "Education - Administration, 78220-1909, F.I.P.", relative to the admission of Manuel Hidalgo, a Porto Rican student, this is to report that the young man will be admitted at Carlisle.

I am asking the Commissioner of Education of the island of Porto Rico to forward me the checks to cover his tuition and so that the balance of the amount of his scholarship may be placed to his credit in the school bank and then expended under proper supervision.

Sir:

The Office has received your letter of September 28, with regard to the enrolment of Manuel Hidalgo, a Porto Rican, who has a fourly ears scholarship amounting to \$250 annually from the Government of Porto Rico.

As a month has elapsed since the arrival of this young man, you have had some opportunity to test the advisability of enrolling him. The law which permits the enrolment of white children in Indian Boarding Schools on the payment of a proper tuition fee, contemplates the admission only of those whose presence and association would be of advantage to the Indian pupils. If Manuel Hidalgo is of this class, you may enroll him; but he must not be favored in any way above the Indian pupils by exemption from routine duties, by being provided with special teachers, or having any special privileges.

The tuition fee should not be less than \$167 per annum. Monthly payments would be proper, if it is your opinion that the

boy should be admitted. Please advise of the action you take.

hundred and fifty dollars (250) annually, payable in twelve
monthly installments. This is probably his entire asset and any leniency you may show him in the matter of
paying his tuition in advance, will be greatly appreciated.

I believe Mr. Hidalgo is an earnest young man, and any interest you may show him or anything you may do to aid him in getting a start at your Institution, will be greatly appreciated.

The Superintendent, Carlisle Industrial School, Carlisle, Pennsylvania.

Sir:

We are sending one of our young men to your school under a scholarship of \$250.00 a year, for four years. Payments will be made to him from this office monthly consisting of \$20.83. As the expense of travel will use a great part of his first three checks, we trust that you will do all that you can to aid him to obtain necessary articles, etc., until the arrival of his next check. Also we beg that you will do all you can to help the young man in his future life there.

As the boat that Mr. Hidalgo goes to the States on, will arrive in New York about the 20th, he should reach Carlisle about the 21st. If someone could meet him at the station in Carlisle, we believe that it would aid the young man quite a little and at the same time would be greatly appreciated by this Department.
