The Honorable, Commissioner of Indian Affairs, Washington, D. C.

Sir:

This is to report that Raymond Kennedy has been living with the family of Mr. E. W. Fulper at Stewartsville, New Jersey, since April 1st of this year. He was sent to Mr. Fulper's home under our Outing System and in order to afford him a chance to take up the machinist trade. Raymond has not been released from the school for the reason that he is stationed in one of our Outing districts and that it has been deemed best for the discipline of the students in that district not to discontinue having him under the discipline of the school. The young man is doing well and with the help and encouragement that can be given him it is only a question of time when he can be released and when he will be able to finish his trade without further supervision. For the present I am of the opinion that it would be a serious mistake to release him.

Correspondence that passed between Raymond and this school is copied below:

Under date of June 8th, Raymond wrote as follows:
"I am taking this opportunity of writing you

a few lines in regard to my release from the Carlisle Indian School. My time of five years are up this month, and as I expect to make or keep my home with the Rev. E. W. Fulper all business will be in his hands. I am very thankful that I am left to fight a few of the early battles and realize that there is a great future before me. I am also thankful that I have some one to look out for my general welfare, such as the Rev. Fulper. It certainly is trying to come in contact with so many strange people, further to be in their midst constantly. Above all I appreciate your goodness in permitting me to come out at the early period that I did. Well, as time is late and I have to get up early will close, sending my best regards to the school".

Under date of June 15th the following reply was sent to Raymond:

"Your letter of June the 6th has been received and all of us are pleased to learn that you are getting along so well. This is the time when you will have to learn many lessons that could not be taught you at school, and under the care and guidance of the Rev. Mr. Fulper, I have confidence that you will meet with greater success in your work.

Before considering definitely the matter concerning your release from the school, I wish to call your attention to the fact that if you are dropped from the rolls now you will not be entitled to your transportation home at any time in the future, and that no financial assistance can be given you from the school.

Please give this matter your consideration, and let me hear from you again".

The following reply was received from Raymond under date of June 28th.

"I received your letter in regards to a release from the school as I have served my time of five years. The Rev. Fulper and I have considered the question and both agree

to a release having served my time. The matter of carfare will be considered when I go home, as I do not intend to go yet. So you will please send me a check on my means there, and my account be closed as I desire to fight the battles of life as they come. I also thank the school for the great experience I gained while there. I now close awaiting your answer. My best regards to a bright and happy future of the school".

Under date of June 30th, we replied as follows:

"Your letter of June the 28th has been received. After considering carefully your request to be released from the school, it has been decided not to grant you the same until after you have given your position a longer trial.

It is true that your period of enrolment has terminated, but you are now located in one of our Outing districts, and if you are released from the school, it is natural that you would have certain privileges not allowed the boys under the jurisdiction of the school. Some of them would be too young to see that you are entitled to special privileges and dissatisfaction would result, causing you and the school unpleasantries.

If you are in need of the money now to your credit here, arrangements can be made to forward that to you, but for the reasons above noted, I would suggest that you continue with the Rev. Mr. Fulper as under the present arrangements".

On July 1st, Raymond wrote as follows:

"Your letter of the 30th received and was very much disappointed in not being allowed to sever my relations with the school after having served my time. I do not have a permanent position - it is an uncertainty owing to the fact that it is dangerous and not knowing when the machine will go down and then I would be laid off. The arrangements made at leaving the

school were that I go out under the Outing rules until my time expired and now the expired time is here and I fail to be released. As I expect to stay here, I pay board and furnish myself with clothing and we have a room here which I would like to furnish for myself, seeing that we get so much company and no place to keep them and if I furnish my own room that will leave us more room for company, and if I should get the necessaries and send you the bill would you please send me a check for the amount? I am in the best of health and enjoying that work I have although not very pleasant. I close sending best regards to all".

On July 6th, the following reply was sent:

"Your letter of July the 1st has been received and the contents of the same noted. I am glad to learn while you are disappointed in not being released from the school, yet you realize that we are trying to do what is deemed best for your own best interests. After you become more permanently located and when you are not in need of the more and closer personal attention that can be given you under our Outing System, we shall grant you your request.

As promised in my last letter, we can arrange to let you have such an amount from your credit in bank as you will need for the furnishing of your room. Please let me know what amount you need.

With best wishes for continued success, I am,"

Since the above was written Raymond has been sent a check for the amount of money he desired. It seems that he requested his release in order that he could draw his money from our school bank. He has not asked since for his release from the school and he is continuing to make progress with his work.
