Sir:

The Office has a letter from Rosa Monroe, a former pupil of your school, saying that the father of Nellie Cuttler, Mary Ann Cuttler and Christine Cuttler, aged 14, 12 and 10 years respectively, is desirous of enrolling the children at Carlisle.

In view of the fact that the mother of these children is dead, that the father is anxious to keep them together, and that you will be glad to receive them, you may consider their formal applications and if found satisfactory in all respect, excepting as to age, the Office will impose no objection to their enrolment.

It must be understood, however, that the government cannot pay the traveling expenses of the two children under fourteen years of age as the law prohibits this, and this fact should be made clear to Miss Monroe when you write her.
