He shows unusual ability and is ambitious, but without a college training he can never be expected to make a success of his profession.

During the time John has been enrolled at Carlisle his conduct has always been above reproach.

The Commissioner  
of Indian Affairs:

Sir:

Some time this winter, about two months ago, two commissioners came to the school, Mr. Light and another man, I do not know his name. They were taking records of the students as to their home conditions before they came. I think their chief object is to find out how near schools they live, and those that live near schools, they put on a list to send them home this fall. I was informed last week I was placed on the list to go home.

For the past two years I have been working for Mr. M. I. Kast, an architect in Harrisburg, under the outing. Mr. Friedman and I had planned that after getting practical training in architecture I was to get a college education, and take the special course in some university, a two year course, and this requires practical office training before you can get in, two years. Now this has come in and has spoiled our plans, and I came here to see if I could stay during the winter and take a course in mathematics in Conway Hall in town that would fit me for college next year. Since my mother's death I have no home accessible to any public school.
