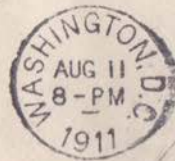

I was a student at the Carlisle
Indian School last year, and was declared
incompetent last spring so I had to leave.
I wrote to Mr. Friedman last week to see
if there was any possible way of my getting
back and he advised me to write to
Washington. Now I'm a poor boy working
my way in this world. I was attending
Conway at Carlisle and would like to get
to college very much, but I haven't got the
means, I had all I could do, to pay my
fees there which was \$8 a year I'm out
here just now working, I am originally
from New York, my mother is dead and
my father drinks I can't depend on him
very much

I would be perfectly willing to pay the
government but as I said I have nothing
to pay with, it is even hard for me to
get \$80 in one summer. sincerely
hoping that you will help me in every
possible way, I claim to be a full
Blood Mohawk Indian but they put me
down as three quarters at the Indian
School, hoping you will give this letter
a very serious consideration. I remain.
