Sir:

Referring to Office telegram dated November the 13th, this is to report that when Superintendent Hart of the Oneida School submitted to me May Wheelock's desire to return to Carlisle to complete the work of our Senior year I informed him that permission for her enrolment would be requested of the Office if she could arrange to provide transportation for her return. I was advised later that she was not able financially to do so, and for the reason that she was very anxious to return to school to complete the course and for the additional reason that she acted as an escort to a party of eight other students who were transferred to Carlisle by Superintendent Hart I recommend that transportation for her be paid out of Government funds and that authority be granted me to enroll the young lady.


May is not very strong physically, but is a bright student and an earnest worker and I believe that every chance

Sir:-

A party of students is being recruited on the Oneida Reservation for the Carlisle Indian School. I understand it is against the rules of the Department to admit to this institution, pupils who are over 21 years of age, and who on account of their scholastic standing, would not likely remain there longer than one year.

Miss May Wheelock came home from the Carlisle Indian School last summer for her vacation, intending to return to the same school with the party which is now being organized at Oneida. But she has been advised by the Superintendent that because she has passed the 21 year period of her existence, and was a Senior of the class of 1913 at Carlisle, she could not be permitted to return. Miss Wheelock tells me that had she been aware that the conditions above mentioned existed, she would not have returned to the Oneida Reservation.

It seems to me under the circumstances, and in view of the fact that the denial of the office to have her return, is an injustice, I would ask, that the above regulations be disregarded in this instance and permit her to be taken back at the school, so that she can graduate with her class for

which purpose she has attended this school for the past  
eight years.

The party is expected to leave Oneida within ten days  
and I ask that unless the Superintendent of the Carlisle  
Indian School objects, that Mr. Hart provide transportation  
for Miss Wheelock, whenever the party now being organized,  
starts for Carlisle.

I am sending a copy of this letter to the <sup>Supt. of the</sup> Carlisle  
Indian School for his information.
