I have received your letter of March 1, 1912, enclosing a communication to you from J. Louis Hill of Now Moxico, requesting the enrollment of his son at the Carlicle School, Pennsylvania, because of his need of discipline.

It is now the policy of the Indian Office not to enroll Indian pupils who have access to the public schools.

In this instance Mr. Hill says that his son attended school at El Paso, Texas and ran away to be a soldior. If this was a public school it is evident that his son was not only within reach of public schools, but his eligibility thereto was shown. If the school he attended was a private or denominational school and he was not entitled to public school facilities, he might under

school. In this case he should make application to the Superintendent of the school in which he desires to be enrolled. He will be furnished with an application blank calling for certain information, and if this shows he is clearly entitled to be enrolled, the Superintendent will enroll him, but if there be any doubt in reference to the matter, the Superintendent will refer it to the Office for consideration.

Unless it shall appear that Indian pupils are ineligible for enrollment in the public schools, or for other reasons have not access to them, it is believed they should not be enrolled in an Indian School.


