Sir:

The Office has your letter of March 21, and copies of correspondence concerning the application of Raymond Ross, a Cherokee Indian of Oklahoma, for enrollment in the Carlisle Indian School.

It has been the long settled policy of the Office not to permit enrollment in Government Schools of members of the Five Civilized Tribes.

Exception has been made in the case of Haskell and Chilocco only, and the rule with these exceptions has been embodied in paragraph XXI to Circular 464.

which has been made in any case, and the applications have been uniformly denied.

the rule, however, applies only to maintenance and tuition at Government expense, and if the boy's father is willing to pay the customary charge for tuition at Carlisle which is

understood to be \$167, per annum and also his expenses for transportation there will be no objection to his adopting this course.






