Sir:-

I transmit herewith a communication from Hon. Moses E. Clapp, U. S. Senator, together with a letter and application blank for the enrollment of Harold E. Bruce, a one-eighth blood Indian, and respectfully recommend that authority be granted me to enroll this young man. His application indicates the possession of one-eighth Indian blood, and the application blank and letter indicate that his mother is a widow and that they have no means to continue keeping him in public schools any longer. There is plenty of room at the school for any number of Indians from the reservation who may enter in compliance with the regulations, so that no one with the required Indian blood will be crowded out by the admission of this young man.
