Sir:

I have your letter of February 24, in which you request permission to enroll in an Indian school. The nearest school to Washington is that situated at Carlisle, Pennsylvania. This carries pupils through the eighth grade in academic work. From the character of the letter which you have written, it seems that our schools would scarcely be of much value to you, for you have at least as good a knowledge of English as have pupils who have finished the eighth grade.

There is also a course at Carlisle in commercial branches, but unless you are positive that you want to do clerical work and have ability along that line, you would not be justified in spending the time necessary in completing such a course.

One can also get excellent training at this school in the trades, such as carpentry, masonry, brick laying, tailoring, etc., but this training would not be of value to you unless you have decided that one of the

trades will furnish you a better means of earning a livelihood than you now have.

You say you have been earning your own livelihood, and because of this fact there does not appear from your letter to be any good reasons for your entering one of our schools. However, if you wish to present more facts in reference to the matter, or desire to call at the Office and discuss this question personally, you are at liberty to do so.
