Neither the Carlisle School nor any other school in the Indian Service of the United States teaches the profession of dentistry. The Indian schools have academic departments which carry their students through the eighth grade only, and also courses in various branches of industrial work, as for example, carpentry, blacksmithing, farming, gardening, mechanical engineering, etc.
