Office letter dated December 3, 1914, relative to the enrollment at Carlisle of Brown Eagle, a Navajo Indian 23 years of age, has been forwarded to me here. Regarding this matter, I have to state that if Carlisle is the only school in which Brown Eagle can receive the training he desires and that is best suited to his needs, all things considered, I am willing to waive our rules and admit him. If, however, he can be provided for in some of the smaller schools nearer the Navajo country, I should think it would be the part of economy, and for the general welfare of the service to require him to go to either Albuquerque or Santa Fe. In any event, he would have to pay his own transportation from his home to the school as he is more than 21 years of age. We are very anxious at Carlisle to enroll only those who have completed the 4th grade, and except in cases where dull students desire to learn some trade which they cannot learn at any other school, we would prefer not to enroll any students below that grade.

S i r : -

In reply to the Assistant Commissioner's letter (129387-1914) of the fifth instant, relative to Brown Eagle, a Navajo Indian, I will say that there are here at present six young Indians who are not sufficiently advanced to warrant their being classified above Grade I. Some time ago, the undersigned was advised by the Supervisor in Charge that, in accordance with arrangements made with the Honorable the Commissioner of Indian Affairs, no more students would be admitted to Carlisle who were unable to qualify for at least Grade Four. It has been our desire to eliminate Grade I from this school within a few months from now. If Brown Eagle were to enter now, he would be three months behind the six who are carried as Grade I pupils. However, if it is the Honorable Commissioner's wish that Brown Eagle be admitted here, we shall enter no objection and shall cheerfully do the best we can for him.

Brown Eagle, a Navajo Indian, twenty-three years of age, has appealed to the Office for permission to enter one of our Indian schools.

His parents are dead and he has not been with his people for approximately ten years, having spent practically all of this time with shows. He was enrolled at Haskell Institute about ten years ago but after staying there two ~~years~~ ^{months} ran away. He has no education, being unable to either read or write, and seems to realize the necessity for acquiring this knowledge.

File The Office has no objection to his enrollment at Carlisle provided you so recommend, as it is understood you have a class at your school for students who are advanced in years but deficient in education.

Please reply immediately, submitting your recommendation.
