The Office is in receipt of your letter of December 14 with its inclosure pertaining to the request of Louis Scott to be permitted to attend the Carlisle Indian School.

In this connection, attention is called to Section 12 of the rules for the Indian School Service providing that young men and women who have passed the age of 21, but who have not had adequate opportunities for industrial training may be enrolled in Indian schools provided they pay their own transportation expenses.

Under these regulations, it seems to the Office that Louis Scott should attend the Chilocco school which is nearer to his present home, and where he will have ample educational opportunities.

The inclosures to your letter are herewith returned. If there are good reasons for choosing Carlisle school instead of the Chilocco school, and this young man is willing and able to pay his transportation expenses there will be
