My dear Mr. Commissioner:

Referring to the application of Henry Flood for enrollment in the Carlisle Indian School for the purpose of attending Conway Hall Preparatory School, I unhesitatingly recommend that the request be granted.

I have known Mr. Flood for about ten years. He enrolled at Haskell Institute as a mere boy and during all the years of his stay in that school he was an exemplary student. He is a young man of good habits, is studious, always loyal to the interests of the institution with which he is connected, is ambitious, and has much more than ordinary perseverance. I believe that he will make good use of the opportunity to continue his education at Conway Hall if permitted to enroll and live at Carlisle.

In the event that he should at any time not make

good use of the opportunity thus given him such privilege should be withdrawn. It might be well for him to understand that he will be permitted to remain until he can complete the course provided he is a worthy student, but that otherwise he will not.

I respectfully submit for the consideration of the Office correspondence relative to the proposed enrolment at Carlisle of Henry J. Flood and an approved application for his enrolment.

I beg leave to state further that no other Indian student would have to be deprived of enrolment at Carlisle if permission were given the young man to enroll here to pursue his studies at the Conway Hall or Dickinson College. On account of his age he would have to pay for his transportation from his own funds and only for his housing and his board would the Government have to provide. His tuition fees would have to be paid from his own funds.
