My Friend:

I have your letter of April 14, 1917, enclosing your photograph and requesting to be enrolled in the Carlisle Indian School. I am glad to know, by the letters of the Superintendent of the Mount Pleasant School, that your record is excellent. It seems to me, however, that you should remain where you are while you have the advantage of the public high school. You appear already to have acquired a very good education and the places in the Indian schools should be reserved for those who have not had the opportunity and who are younger than you.

Under the circumstances your request for enrollment is denied unless Mr. Cochran, Superintendent of the Mount Pleasant School can furnish special reasons for your enrollment at Carlisle.

My principal idea is this, I wish to board and room at the Indian School, and attend the city High School.

I am an Ottawa Indian, twenty four years old; and I realize I must have a special permit. I will pay all transportation funds and school books.

I wish to participate in all of Carlisle Indian school activities, such as foot ball, base ball, basket ball, physical training and military tactics; and obey all rules and regulations of the Carlisle Indian School in Pennsylvania.
