

My dear Mr. Francis:

Susan Godfrey, mother of Frank and Louis Godfrey, 2 young men in your school, came into the office this date and requested that I write you to send Frank, the younger son home to work and help support his mother. Mrs. Godfrey has been sick for several months and is unable to work. She has a son here about 14 years of age who is going to the Catholic school. This boy is too young to support his mother.

Frank, I believe, signed for 5 years. Three years of his time is up. I regret very much to recommend for this boy to come home before he graduates but in view of the condition of the mother, I believe that he should be permitted to come home.
