Sir:

In accordance with your recommendation of May 21, you are hereby authorized to expel Agnes Bartholomeau and Edith Rainy from the Carlisle School, and to provide transportation for the return to their homes at Sparta, Illinois, and Rossfork, Idaho, respectively.

After these girls have been placed in charge of their parents or guardians, you should take up their care with their home superintendent, and he can doubtless perfect a plan which will enable him to render them further aid or protection.

Please notify these girls that they cannot be enrolled at any other Indian School unless by special permission of the Commissioner of Indian Affairs. The Superintendents or the other nonreservation schools should also be told that they will not be permitted to receive them except on the above condition.
