Sir:

Referring again to the matter that was brought to the attention of Superintendent Howard of the White Earth Agency in my letter of April the 15th, and of which a copy was sent to the Office with my letter of that same date, this is to report that the Philadelphia Agent of the Northern Pacific Railway Company has again urged me to make payment of the amount due for the transportation that was furnished at Detroit, Minnesota, in November, last, for Earl Armstrong's passage to Carlisle.

Mr. Pummill's letter is attached hereto, together with the copy of the reply that has been addressed to him.

In view of the fact that Superintendent Howard has not yet taken action, and has not advised me that there are funds available from which the payment can be made by Armstrong, I respectfully request that authority be granted me to settle the indebtedness from Government funds, with the understanding,


however, that when Armstrong has any funds from which the payment can be made that then an amount of \$53.09 be sent here with which the Transportation fund can be reimbursed.

The amount due the Northern Pacific Railway Company is \$30.54. The balance of \$18.55 is an amount that had to be expended in returning Armstrong to this school from Erie, Pennsylvania, when he had deserted and had reached that city.

Sir:

I am forwarding herewith letter received from Mr. Chas. F. Peirce, Superintendent, U. S. Indian School, Flandreau, S. D., relative to Anderson Armstrong, a pupil at this school who was expelled from the Flandreau School last summer. This boy ran away from here a few weeks ago and was apprehended and returned to this school. I knew nothing of his having been expelled from Flandreau until so advised by Superintendent Peirce. In my opinion it is decidedly wrong to enroll and retain in this school pupils who have been expelled from other schools. I, therefore, recommend that the Office direct me to expel this pupil from this school as recommended by Superintendent Peirce.

I have had considerable correspondence with Mr. Friedman relative to his retaining Anderson Armstrong as a pupil. This boy was expelled from our school last summer and returned to White Earth, Minn. While there he applied to Agent Howard for transfer to Carlisle School under the name of Earl Armstrong. I followed the matter up with several letters to Mr. Friedman and the last I heard of the matter was that Mr. Friedman had called upon Supt. Howard to furnish the return transportation. I understand that the boy is still at Carlisle and I wish to protest against his being continued there. He has been writing to our pupils all the winter and seems to glory in the fact that he was able to go to Carlisle and that he is having a good time. He has written several boys that as soon as the ball playing season opened he will skip. Now he is simply working this scheme to obtain clothes, lodging, etc., during the winter months and I do not feel that this procedure is proper. As I wrote Mr. Friedman some months ago, the enrolling of expelled pupils was demoralizing to the discipline of all schools and I believe that Anderson should be fired from there.

I do not know how he is fixed at present but he has had money sufficient to pay his own expense back to White Earth. At all events I feel that he should not be harbored at Carlisle any longer.
