I have the honor to acknowledge receipt of the above noted communication, and in reply thereto to state that Adeline Thorpe is a young woman 17 years of age. She recently completed a term at Chilocco School and has entered Chilocco for another term of three years. I do not think it wise for her to make a change at this time. Edward Thorpe is only 13 years of age and is not, therefore, eligible to transfer to a non-reservation school. I believe it advisable for him to remain at the Agency School for another year, first, for the reason that he is not of proper age for transfer, second, that the attendance at the Agency School this year will not be up to capacity, and third, that there will probably be more applications for attendance at Carlisle than can be accommodated there.

In this connection the attention of the Office is invited to the fact that James Thorpe, brother of these pupils, who desires to have them enrolled at Carlisle so that they may be in the same school with himself, is 25 years of age, and will not in all probability be at Carlisle for any extended period of time. In fact it is my opinion, it is now time he should be out earning his

I have the honor to acknowledge receipt of your Office letter, reference above, bearing date Sept. 10, 1912, regarding the proposed transfer of Adeline Thorpe from Chilocco to Carlisle.

Adeline's term expired this summer and she has just signed for herself an application for another three years.

So far as the benefit of the girl is concerned I am constrained to believe that it will be much better for her to remain in the school with which she is acquainted and where her peculiar temperament and disposition are known to her teachers. She and her brother have been separated for many years and both are grown. Any way it is not my understanding that the brother remains at Carlisle throughout the year as the ordinary students do, though I may be mistaken in that. The

objection that I have to her transfer is based upon what seems to me the best interest of the girl herself and the discouraging of the tendency of Indian children to go from school to school, thus entailing additional expense upon the Government for transportation merely to gratify their desire to roam about. I find that students who have that bent gratified usually do most unsatisfactory work. Adeline is only completing the Sixth Grade now and it will require two years or more for her to finish the grammar school. While I am confident that her interests lie in her staying at Chilocco, I shall very willingly be guided by the action of your Office.
