Sir:

Referring to Office letter marked "Education - Administration, 40722-1909, H.S.", dated May 28th and relative to the request of Clarence De Graff that he should be granted permission to return to his home and to continue his education there, I respectfully forward you herewith for your examination all the correspondence we have had with the mother of this young man, together with the application blank properly filled out and giving consent to his original enrolment.

I have to report further that this young man is now 21 years of age and that he has been enrolled here since September of 1907. He was enrolled for a five year term, which would expire with the close of the school year in June of 1912. The mother has vouched to the fact that the young man is a quarter blood Indian.

I further beg leave to respectfully recommend that this young man's request should not be granted him, as it is evidenced by the mother's letters that she is

not concerned about the future education of her son, but that she is making her plea on the strength of what assistance he could render her at home, or probably to satisfy a whim of the young man's to be allowed to come home.

Permission has already been granted the mother for the return of her son as evidenced by my letter of May 14th, but to discharge him from the school would now seem to thwart the policy of the Office that he be educated somewhere, as well as interfere with the discipline of the school.


