Dear Sir.

The blank you sent me containing questions about myself just arrived; so I filled it out <sup>the</sup> best I could. I suppose you never hear anything about me since I left the school in 1908. You know I left May 25 1908. I traveled on the train 6 days and 5 nights to Seattle and from there, it took me 15 days to <sup>reach</sup> Nome.

We <sup>were</sup> delayed by the ice <sup>the</sup> third day after we left Seattle. You know I was not feeling very well when I left, and <sup>the</sup> doctor thought I would never get well.

But I made up my mind that I <sup>was</sup> going to get well when I <sup>got</sup> up here in Alaska; and I stood by what I said to myself. It looked pretty blue for me <sup>for a</sup> few weeks after I arrived, but

I kept on saying that I ~~am~~<sup>was</sup> going to get well, even if everything ~~is~~<sup>was</sup> against me but God. So ~~my~~<sup>and I am</sup> dear friend, Mr. Friedman, I got well, just like a new man!

I've got no property or money to speak of, but I earn enough to make <sup>a</sup> comfortable home for my wife and baby. In ~~a~~<sup>the</sup> fall of 1908, I started to <sup>work</sup> for B. A. Keller, the leading merchant of Council City, drawing sixty dollars a month, and next year I got 75<sup>00</sup> per month, and this year \$100<sup>00</sup> a month. So you see this sum of money ought to keep a man comfortably.
