My dear Mr. Henderson:

I regret very much to advise you that Lucinda Reed, who is enrolled here from the Agency under your jurisdiction, is in a pregnant condition and that I must ask you to co-operate with me in caring for the girl. I understand that her parents are dead, so before arrangements are made to send her to her home I would thank you to advise me what can be done to insure proper protection and care if she is sent home. Your prompt consideration of this request will be appreciated.

In brief Lucinda's story is about as follows: It seems that when she was at her Outing home at Cynwyd last summer it was the custom for her to go across the street from her home each Sunday afternoon to the home where another of our girls, Margaret Brown, was staying and that then both girls went on to Bala to visit with Jane Owl during the afternoon. About the last Sunday in July, it is claimed by Lucinda, Margaret Brown had already left her home when she (Lucinda) got there and that then she

started off by herself ~~ix~~ for her usual visit with Jane.

On the way she seems to have met a young man who greeted her. After she had answered his greeting he engaged her in conversation with the result that she accompanied him for a walk and spent the afternoon with him.

Lucinda claims that she had never seen the young man before and that she has not seen him since, and that he refused to tell her his name when she asked him to do so.

Mrs. A. H. Holcombe of Cynwyd, with whom Lucinda spent the summer, has been asked to make an explanation and it is hoped additional information can then be gotten which may result in identifying the young man who is evidently responsible for the girl's downfall.

except in daylight on
Sunday afternoons and
the walk between the homes
is along much travelled
streets. She was never allowed
to go even to the Post
Office except with one or
more of our children.

She was unwell about
the middle of August as
her last naphkins were
scalded just before she
returned to school.

Miss Johnstone will recall that
I spoke to her (she felt Lucinda
came to me), about Lucinda's
suggestive correspondence
with a boy named Harold
Gilbert. She also was very fond
of one of the young men in
the foot-ball squad and
wrote to me on Nov. 23rd of her delight
at having been his selected

me to go to the Penn - Indian
game in Phila. He did not
mention his name. I have
a great deal of sympathy for
this poor girl but I am much
disappointed that she would
attempt to throw the blame for
her trouble on my lack of
watchful care while she was
with me. I am sorry that
I can give you no further
information. I shall be interested
when you discover the real truth
of the matter.



I would suggest that you provide her with an outfit of clothing for herself and for her child. She is coming to a place where they have no sewing machine and where money is exceedingly scarce. The clothing mentioned would prevent her and her child from suffering. I will do all I can to see that she is well cared for and receives the proper medical attention.

Dear Mr. Henderson:

Referring to previous correspondence relative to Lucinda Reed, I have to advise that she will leave here Thursday afternoon at 2:11, January 28th, with transportation to Whittier. One of the teachers will accompany her as far as Washington, D. C. If you will have someone meet her at the railway station there, we will pay any expenses incurred thereby, upon receipt of the properly prepared voucher. The matron has taken considerable pains to have prepared for Lucinda's need articles of clothing, so that she is well outfitted. Later a package too will be sent to you for her use. This whole affair is to be regretted, but there appears to be no one to blame but Lucinda herself.

In this connection, I desire to call your attention to the importance of sending to Carlisle only such students as have some purpose and ambition. We have expended a great deal of money this year in weeding out undesirable pupils, and unless we can fill the school with students who desire to profit by the opportunities here offered, it is a waste of time, energy and money. I believe more real good for the

Mr. J. E. H....#2.

Indian race would be accomplished with only a few hundred desirable students, than to undertake to crowd the school with a lot of undesirables.

Generally speaking, however, I believe the students we receive from your reservation are very desirable and in spite of all precautions I realize that occasionally we will get one who is not desirable. Just now we are taking in no students at Carlisle who are not especially recommended, and we have been turning away a great many who have school advantages near their home, or who for other reasons are not deemed desirable to enroll at Carlisle.

Dear Sir:—

It is impossible to express our annoyance and surprise at learning from Miss Johnston that it is now being rumored that our son is the father of the child born to Lucinda Reed last year. We can not understand how such a maliciously false tale could be started except as an indirect result of the absolutely false and rotten story which we learn has been told by Eva Jones. Your files contain a letter which Mrs. Holcombe found on Eva's desk which intimates very plainly that she and Jane Owl had a secret scheme to get back to Carlisle before Christmas 1914. Your records will show how Mrs. Philips handled this matter with her girl and at about the same time Mr. Dickey took Eva from our home because of her continual defiance and insubordination in school and at home. Our son is an active boy of 16 years who leads his class in High School and whose spare time for several years has been spent in the work of the Boy Scouts. He has never had much time for girls and has never shown more than common civility to any of your pupils who have been in our home. It is a

perfect outrage that irresponsible people should circulate such false rumors against us in a way from which we have no defense. Mrs. Holcombe and I have always taken a great deal of interest in the girls you have sent us and have faithfully tried to help them in every way not only to learn as much as possible but also to build strong characters. We have tried to treat them not as servants but as helpers in our home and they have been allowed as much as possible to share in our family pleasures. Eva Jones however was so filthy about her person that our children did not wish to be near her.
