My parents were in the service for several years at the Leach Lake Agency and the Standing Rock Agency.

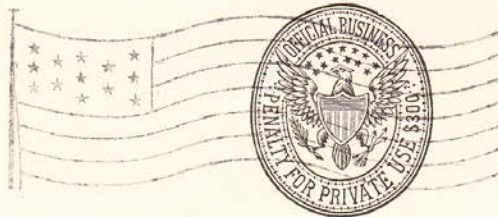
