6. What property in the way of land, stock, buildings, or money do you have? We have a fine farm of 200 acres and a six roomed cottage in Sapaw Agency Okla. We have due us at Tolamath Agency, 8 claims of 160 acres about 30 head of cattle and 9 head of horses, have had some money in the bank on deposit.

7. Have you been in the Indian Service? In what positions? How long in each? Have been filling different positions in the Indian Service since coming here from 6 months to over a year. Took a Civil Service Examination on July 21, 1908 for Farmer, successfully passed, was appointed at Tolamath Training School filled the position nearly two years was transferred and promoted to Ft. Hall Idaho resigned owing to business necessity and the caring for of my stock & etc.

Followed the trade for some time. That I learned at Carlisle as a tinner and plumber, have done some carpentering also.

One of the best traits in my life is to do my fellow man some good in the religious way, have fought the evil of liquor at all times. Since coming here. I have ^{brought} the liquor question here in our County as a political issue, being a voter with my assistance and my vote two years ago we voted our County dry, again last year we made great effort to keep the sale of intoxicants out of our County, but we lost. I take considerable interest in all questions relating to the laws of our State and right government.

Have endeavored at all times to keep up the good name of Carlisle, so that Carlisle will not be ashamed to own me as her son. With the best regards and wishes
