I enclose you herewith a check covering the amount of the balance to your credit in our school bank. I trust you will make good use of the money and that it will prove to be of great assistance to you.

Miss Gaither informs me that your trunk was placed in the storeroom at the Girls' quarters soon after your departure from school and that it contained nothing
