The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

If the information called for on any part of the blank is not known, that fact should be stated. No space should be left unfilled. Whether the parents are living or dead, their names must be given.

The person who signs the blank as consenting to the transfer should indicate his relation to the applicant by marking out the word "parent," "guardian," or "next of kin," leaving unmarked only the title appropriate to the signer.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them are living, and if neither of them are living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, That hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case; but in all cases where the parents are living they should first be consulted.





Dear Mrs. Broze:

We have received your letter of February 17, asking for a statement of the attendance of yourself and your brother, under the names of Lucy and Harry Charles, at the Carlisle and Toledo Indian schools. You say that you have been asked to furnish birth certificates but are unable to do so since your births were not recorded.

Lucy Charles' application for enrollment at Carlisle Indian School, Pennsylvania, shows that she was born in 1895. In 1900 she was enrolled at the Orphans' Home at Ottawatomie, Minnesota and was transferred to the Toledo Indian School, Iowa, in 1905. She was transferred to Carlisle on November 2, 1910, for a period of five years. She left Carlisle at the expiration of the five-year enrollment period.

Harry Charles' application for enrollment at Carlisle Indian School, Pennsylvania, shows that he was born August 6, 1897. He was enrolled at the Orphans' Home at Ottawatomie, Minnesota, until 1906, when he transferred to the Toledo Indian School, Iowa. He was transferred to Carlisle on June 28, 1911, for a period of five years. After the expiration of his enrollment period, he reentered Carlisle, on December 23, 1917, and left January 4, 1918, to be married.

We hope that the above information, as shown by the Carlisle records, will be of help to you. An extra copy of this letter is enclosed for the convenience of Charles

I am just back from the west, and write at my earliest opportunity concerning the parents of Lucile and Harry Charles.

I regret that I have no pleasant news to tell. Their father, William Charles (whose correct name I have been told is Lawrence) from all accounts is a worthless vagabond. In blood he is partly white, partly Brotherton, not Stockbridge, Indian, and possibly a little negro. One report has it that he is at Redwood Falls, Minn., another that he is dead - which latter I hope for the childrens' sake. His wife, Nancy Charles, now on the Stockbridge and Munsee Reservation adjoining the Menomini one, is divorced from him. I have not been able to find out anything else about her, and there appears to be some doubt if she is the mother of Lucile and Harry. It is barely possible that if you communicate with Mrs. William Welch of Belleview, Minn. she may be able to give you some additional information.

I am glad to have you write me and ask me about the matters which are puzzling you. I am glad to see that you are interested in your school work and that you feel the necessity of as much education as you can afford to get.

It is not necessary that you be in eighth grade before you can become a pupil in this school. The Vocational work begins with the 6th grade and we have a Pre-Vocational course which admits pupils in the grades below the 6th.

There is one thing which might make you non-eligible for re-enrolment at Carlisle should you go to your father's home at Redwood Falls, Minnesota. You would have access to public school out there and the Indian Office might demand that you attend school there rather than at Carlisle.

While I know that it has been a long time since you have seen your father and other relatives and while I appreciate your feeling about seeing them, I would like very much to have you extend your term another two or three years or even one year.

You could remain under the outing this summer, return to Carlisle in September and try a year of our new course. If it is what you think you will need to prepare you for your life's work, you can then consider the advisability of enrolling for a longer term. I am in receipt of your letter regarding
Harry Charles.

In response you are advised that upon his return to the school I had him brought before me immediately and he informed me of all the facts concerning his relationship with your daughter. In view of this I feel that he should return at once and arrangements should be made for the marriage at an early date.

You must understand, of course, that in view of Harry's statement to me that this marriage must take place. When it does take place I shall drop him from the rolls of the school.
