To Graduates and Ex-Students of Carlisle, Greetings:

As you have no doubt noticed the last issue of The Arrow was a combination issue of The Arrow and Red Man, the two publications which have heretofore been published at the Carlisle Indian School.

Owing to the increased cost of all supplies for the school and particularly of all materials going into the make-up of a newspaper or magazine, it has been deemed advisable to continue The Arrow as heretofore but to combine the issue, on the first week of the month, with The Red Man under the caption, The Carlisle Arrow and Red Man.

The material usually found in The Arrow will be in the combined issue, together with such other leading articles and information as may be collected of interest to Indians, Indian Service employees, and other friends and well-wishers of the Indian race.

The regular subscription price will be One Dollar a year payable in advance, but to all ex-students of the school a special rate of Fifty Cents a year is made. This is within the reach of every one.

Carlisle is your school. Its continued success reflects yours. It has given to you of its best. As a further evidence of its interest in you, you are offered the privilege of becoming a paid subscriber, at the reduced rate, to the paper and magazine that will come to you each week during the school year bearing welcome news of your beloved school.

You need The Arrow, and The Arrow needs you. Every loyal ex-Student should keep in touch with his school. This is your opportunity. Be true to your colors.

It will be our endeavor to make the new magazine issue newsy, interesting, and instructive, and we hope the change will be to your liking.

With the issue of October 26th, all free subscriptions will be dropped. Use enclosed card for mailing your fifty cents.

My dear Sir:

I have noted the information you brought to my attention in your letter of recent date regarding an amount of money you left here when you deserted from this school.

The records on file here indicate that on December the 31st of 1906 your account was closed out by crediting to the "Emergency Fund" the \$52.14 you left here. Since then the money in the "Emergency Fund" has been expended and at this time there is no such money under my jurisdiction.

I do not know in what way such money could be secured for you at this time.
