

INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other non-reservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.



On the night of April 10, 1917

a lady by the name of Mrs. Barron called on me at the request of Father Feeser and advised me that George Francis, a member of the Senior Class of this school, was in the habit of calling on a married woman by the name of Mrs. Shriver, living on North College Street in the City of Carlisle.

It appeared from Mrs. Barron's statement that George Francis had known Mrs. Shriver previous to her marriage to Mr. Shriver which took place in September 1916 and that the Shriviers were separated in February 1917, since which time Francis has been visiting Mrs. Shriver.

Mrs. Barron, herself a Catholic, felt that George Francis, who is a Catholic, was violating the rules of his church by going to see this married woman and for this reason reported the matter to Father Feeser.

Dear Sir;

Being asked to comment upon the case of George Francis,
Captain of the School Band, I will be very frank and just in
my statements.

For the past four years I think the young man has been
a good and faithful student, always doing his duties well. Dur-
ing the past few months he has acquired ~~the~~ association of
a married woman in town, of whom the Superintendent has the
name and address. From time to time the student has absented
himself from the school, missing formations and inspections,
on such occasions the Disciplinarian has reprimanded him
severely, also the superior student officer, this however
seemingly carried no weight.

On Saturday evening, April 21, 1917 this matter was of-
ficially reported by Mr. Francis, our Superintendent to the
Disciplinarian's Office of the Large Boy's Quarters. It was
thought wise by Mr. Welch, the assistant Disciplinarian and
Mr. Corbett, the Night watchman to go down town and watch
the house where the student was supposed to visit frequently.
Upon arriving in town the gentlemen were told by a neighboring
store keeper that an Indian student was in the woman's house
in question.

Mr. Corbett's statement he and Mr. Welch waited in the immediate vicinity of the house from about 10:00 P.M. to about 11:45 P.M. At this time the cadet in question came out of the suspected house, he was placed under arrest and taken to the school, to the Disciplinarian's office. While Mr. Corbett went to the Major's room to get the keys to unlock the drawer where the Guard House keys were kept, the cadet opened the door of the office and ran away. Mr. Welch who was in the office at the time was much surprised at the movement as he had unbounded respect and confidence in the young man.

Many of the Commissioned officers of the school were called up to go in search of the fleeing student, the officers returned at different times stating that they were unable to find him.

Sunday evening after the prayer formation, about 9:00 P.M. the student reported himself to the Disciplinarian's Office, he was asked to take off his uniform and was given some of his own citizen's clothing and was placed in the Guard House where he remains up to this date.

This is to inform you that on the 30th day of last month, I was compelled to expel from this school, your son George, having received the consent of the Commissioner of Indian Affairs to do this.

I enclose herewith a copy of a letter to the Commissioner which explains the cause for which I had to take this action.

I have learned recently that George has gone to Detroit, Michigan, although he left Carlisle presumably for Boston, to which point I gave him his railroad fare.

I am sorry for George that he should have made such a mistake but I hope it may be a lesson which will be helpful.

George Francis, with the permission of Mr. [unclear], became engaged to a girl student of this school and the proposed to get married immediately upon his graduation. I was advised by Father Feezer April 24, 1917, endeavored to persuade George Francis to give up his manner of living Commissioner of Indian Affairs, the fiancée of Francis that Washington, D.C. of his behavior. This was done and Sir: engagement was broken off by the girl.

I have the honor to invite your attention to the case of George Francis, a student of this school from Perry, Maine, of three-fourths Indian blood, 24 years of age and a member of the Senior class. This young man was enrolled on December 9, 1912, ran away July 9, 1914, returned to the school on September 21, 1914, was on leave during the summer of 1915 but re-entered school in September 1915 and has been constantly in attendance at Carlisle since that date. He is a good student and would unquestionably have graduated with his class. He has had an excellent reputation, having been both a non-commissioned officer and a commissioned officer. At the present time he holds the rank of Captain.

About three weeks ago Father Feezer of the Catholic Church who has charge of the work of his Church at this school advised me that he had information to the effect that George had been visiting the home of a married woman in Carlisle. It appeared that this woman was married last September and left her husband during February. Francis had obtained permission from the Major-in-charge

George Francis, with the permission of Mr. Lipps, became engaged to a girl student of this school and they proposed to get married immediately upon his graduation. I was advised by Father Feezer that he had endeavored to persuade George Francis to give up his manner of living and that he felt that it was due the fiancée of Francis that she be notified of his behavior. This was done and the engagement was broken off by the girl.

There was no evidence of misconduct against George Francis other than the fact that he had visited this married woman in Carlisle which is against the rules of the school. I called him into my office and charged him with the offence which he admitted, but denied that there was any improper relationship between them, and I pointed out to him that he had violated the rules of the school through his behavior and that his relationship with this married woman must cease immediately or it would be necessary to take drastic steps against him. He agreed not to leave the grounds without my permission, and I advised the Disciplinarian and night watchman of the matter and told them to keep their eye upon Francis.

On Saturday he was in charge of the Band and was permitted to go to Harrisburg for the Parade and returned with it in the evening. His behavior during the day, as far as I know, was most excellent. Saturday evening, after the return of the Band, the night watchman reported to me that in the absence of the Disciplinarian in Philadelphia Francis had obtained permission from the Major-in-charge

of large boys' quarters to go to Carlisle in the evening a day or so before and had not returned until 1:00 o'clock in the morning. I directed him to have Francis report to me in the morning and in the meantime to keep a close watch upon him. About 11:00 o'clock the report was made that Francis was not in his room. The Disciplinarian and night watchman then proceeded to Carlisle to the address of the married woman and watched the house. About midnight Francis came out and was brought to the school by them. In the Disciplinarian's office, while the night watchman was getting the keys of the Guard House, Francis escaped from the Disciplinarian in charge of him. Word was immediately sent out to the local Police and Station Agents. This made it impossible for him to escape, and Sunday night after taps he returned of his own accord to the office of the Disciplinarian and gave himself up. He is now confined in the Guard House.

In view of all the facts in the case it seems that the only course to take for the good of the discipline of the school is to expel this young man. His age, the fact that he is a member of the Senior class and his rank as a Captain makes him a leader in the school and demands exemplary behavior of him. Viewing his actions with the utmost leniency possible, he was warned that a continuance of his behavior would result in his getting into trouble. He gave his word to desist from the course he was pursuing. This word he deliberately broke. He was found in town without authority

out of hours in direct disregard to the rules of the school. Upon his return to the school, in the custody of its officers, he deliberately took advantage of the fact that he was not forcibly held or detained to run away. He gave himself up simply because he could not get away. In view of all these facts, much as I regret it for I personally like the boy and would gladly help him if I could, I feel that the discipline of the school absolutely demands that he be expelled and I so recommend.

Francis has no money in the custody of the school. He was compelled to pay his own expenses here. He should not be turned out of school and permitted to loaf around the town of Carlisle and injure the school discipline. I recommend, in the absence of legal objection, that I be authorized to pay his way home and see that he goes home.

Pending your action in the case he will remain confined in the Guard House. Please make action on this case special.
