My dear Sir:

Upon receipt of your letter of October the 8th, I referred it and the enclosure therewith to Mr. Dagenett, the Supervisor of Indian Employment, whose office is in Washington, D. C. On October the 15th he replied as follows:

"Acknowledging your letter of October the thirteenth, I am returning the two enclosures you request.

This seems a difficult case to handle, as Mr. Martinez' chances for a elerical position in the Service are nil. Superintendents must have competent stenographers and typewriters to assist them in reducing the piles of work which accumulate. It is unfortunate that a man of such limited vocabulary should have attempted to study for a clerical position, and I doubt if he secures such an assignment, excepting, perhaps in some small place where his personal worth is appreciated.

It would seem the practical course that this man get to work at anything he can find to do, to support his family, rather than to consider his personal preferences as to employment. I cannot

hold out to him a good hope of receiving a tender of appointment to anything in the Indian Service of a clerical nature until he stands qualified thru Civil Service examination as a stenographer and typewriter.

The Indian Application Baank, inclosed, might be sent Mr. Martines in case he wishes to apply for a position of an industrial character. I stand ready to do anything in my power for this man, and can advise him more intelligently after I have seen his answers to the questions on the Blank.


The civil service rules provide that Indians may be given noncompetitive examinations to test their fitness for appointment in the Indian Service at Large as superintendents, teachers, manual training teachers, kindergartners, physicians, matrons, clerks, seamstresses, farmers, and industrial teachers, which examinations shall consist of the same tests of fitness as those applied to other persons seeking appointment through competitive examinations.

This means that you will be required to pass an examination for appointment to any of the above positions. Indians are eligible for appointment to other positions in the Indian School Service without examination.

Answer every question definitely applicable to your sex. A fair English education and ability to speak and write the English language fluently are essential in an Indian employee. It is desired, so far as possible, to give Indians the preference for those positions which they are competent to fill. This means exactly what is stated; competency, good health, and a moral character are the essentials of an efficient employee, as well as a fair English education.

When the application is received your record will be looked up, and then placed on file for future reference. Should the office desire to appoint you, whatever examination is necessary will then be recommended.

It is not considered to be for the interests of the service or the applicant to assign him to a position among his own people. Therefore the Indian Office looks with disfavor upon applications for appointment at home schools.
